# SAFETY

#### What is ABS?



#### FRSC Flags Off Ember Months Campaign In Lagos

he Federal Road Safety Corps (FRSC), Lagos State Sector Command, has flagged off the Ember months campaign in Lagos.

Flagging off the campaign at the Lagos Airport unit command, the State Sector Commander, Babatunde Farinloye, said the command recorded 353 accidents in Lagos with 79 lives lost within the eight months of the year.

According to him, one of the major factors attributed to the losses that were suffered in Lagos State, was speed.

He said the theme for this year's campaign is apt. "Speed thrills but kills, drive responsibly and avoid overloading," he stated.

The commander said the corps no longer refers to accidents as accidents but road traffic crashes because an

accident is an unplanned thing, it is a sudden occurrence but crash is avoidable.

"If you must drive during these ember months, drive safely with caution. There is nothing mythical; it is a fallacy to believe that this period is a time that people must die," he stated.

In her remarks, Airport Unit Commander, Jayeola Fatuase, said the command is a small command with higher responsibilities of ensuring free vehicular movements within the local and international airport community.

Also speaking Managing Director, Skycare Catering Service, Ammouri Mohammed, said motorists should ensure to imbibe and develop the skill of defensive driving, while remaining safe on roads.

# **EDITORIAL**

## How Safe Are the Waterways In Nigeria?

here is no doubting the fact that Nigeria is a blessed country. Aside its natural resources which are avenues of income, it is also endeavoured with natural features that enables it to activate all the modes of transportation-Air, Railway, Road, Water, Pipelines.

According to the National Inland Waterways Authority (NIWA), "Nigeria is blessed with a large resource base of waterways spanning 10,000 kilometres; about 3,800 kilometres is navigable seasonally. Twenty eight of the nation's 36 States can be accessed through water. Nigeria can also link five of its neighbouring countriesBenin Republic (Port Novo), Equatorial Guinea, Cameroon, Chad and Niger Republic by water

"The Rivers Niger and Benue constitute the major channels for inland navigation which include but not limited to the Cross River, Port Novo- Badagry-Lagos waterways, Lekki and Lagos Lagoons, Ogun-Ondo waterways, Benin river, Escravos channel, Nun River, Imo River, Orashi river, Ethiope River Ugwuta lake, Lake Chad and the numerous creeks in the Niger delta."

Hence, aside the other modes, the water mode cannot be underplayed at the expense of others because it helps in linking very remote areas in the country. So, recent incidents occurring on the inland waterways, which has claimed a lot of lives, are developments that are adverse to the growth of the sector.

July last year, four bodies were recovered, while 12 passengers were still missing after the boat they boarded from Mile 2 en route Ibeshe in Ojo area of Lagos State, capsized. The number of casualties may have increased thereafter.

On June 12 this year, about **100 were** feared dead after a boat carrying them down the River Niger in south-western Nigeria capsized. The vessel was carrying around 300 passengers travelling from Kwara state to Niger state after a wedding.

Emir of Patigi Ibrahim Umar Bologi II - the traditional ruler of the area where it happened said river waves overtook the boat and forced it to crash into a tree that had washed into the river, causing the boat to capsize.

Also in September, a boat ferrying more than 100 passengers, mostly women and children, capsized along the Niger River on a Sunday morning. They were travelling to their farmlands in the Gbajibo community, located 251km (156 miles) from Minna, the capital of Niger state, the closest source of emergency response.

And recently, a boat conveying over 80 passengers capsized in the Binneri community of Karim Lamido Local Government Area of Taraba state. The boat is said to have capsized midway through the Benue River on Saturday, October 28 evening. According to reports, the boat was returning from the Mayoreneyo fish market in Ardo-Kola Local Government Area when the accident happened, just 50 minutes after takeoff.

These are not incidents that should be swept under the carpet, as so much is being talked about Road Traffic Crashes (RTC) and aviation crashes and little is being said about safety on our waterways.

The time is now for government to undertake a total review and overhaul of the modus operandi of the whole inland waterways operations, as investigations by Transport Day shows among other infractions like obsolete infrastructure and poor regulatory enforcements, safety measures are hardly adhered.

## **SON Destroys Fake Tyres, Warn Importers**

he Standards Organisation of Nigeria (SON) has destroyed confiscated substandard tyres, electrical cables and fake oil lubricants that run into billions of Naira.

Speaking recently in Lagos during the public destruction of seized substandard items at SON's facility in Lagos, the then Director General of SON, Farouk Salim, said he act of bringing in dangerous substandard products amounts to economic sabotage.

He said the act of bringing in dangerous substandard products amounts to economic sabotage. Salim further said it was one of the reasons the SON went to the last national assembly to review its act and to ensure that peddlers of life-threatening materials are jailed not just fined.



He however lauded the National Assembly for passing the reviewed act, which is awaiting to be assented into law by the President.

The SON DG said the court also approved the destruction of used and substandard tyres as well as fake lubricants that were smuggled into the country through the n a t i o n ' s borderlines.

#### Stakeholders Agree On Bulk Cargo Charges Increment By 100 Percent

h e F e d e r a l Government through t h e N i g e r i a n Shippers Council (NSC), has reduced port terminal charges by 33 per cent. However, the bulk cargo charges was increased by 100 per cent from 125 per cent to 250 per cent.

The changes were highlights of a meeting between the leadership of the Council, Seaport terminal operators, Shipping companies, freight forwarders and relevant stakeholders held recently.

The meeting also increased

the number of free days for cargo storage at the terminals to five days from three days with a view to providing more flexibility for shippers and reduce costs.

Confirming the development, the Director, Public Relations Unit of the Nigerian Shippers Council, Rekiya Dhikru-Yagboyaju said that the previously proposed 600 per cent increase in terminal charges has been reduced to 400 per cent adding that the adjustment aims to strike a balance between the needs of the terminal operators and the shippers.

According to Dhikru-Yagboyaju, besides the reduction in terminal charges, an increase of 100 per cent on bulk cargoes was agreed upon by stakeholders that attended the meeting. A statement of resolutions passed at the meeting said: "Break bulk cargo charges have been increased from 125 per cent to 250 per cent. This adjustment reflects the changing dynamics of the industry and ensures fair compensation for services provided.

"All complaints regarding inefficiencies by the terminal operators will be addressed immediately. This commitment aims to improve overall operations and enhance customer satisfaction.



"The Shippers Council has established a complaints desk at all ports. This dedicated desk will ensure that issues raised by stakeholders are resolved promptly and efficiently.

"Boxes that arrived prior to October 16th will be rated with the old rates. This provision aims to avoid any confusion or discrepancies in billing.

"Further discussions between the terminal operators and the Shippers Council will continue to refine and improve the processes. This ongoing dialogue will ensure that the interests of all parties are considered and addressed.

"By reaching these resolutions, the Nigerian Slippers Council, shipping companies, terminal operators, and relevant associations/stakeholders have demonstrated their commitment to fostering a harmonious working environment and addressing the concerns of the industry."

#### New Heads Of Shippers' Council, NIWA Take Charge

President Bola Ahmed Tinubu recently sacked the Executive Secretary and Chief Executive Officer of the Nigerian Shippers' Council, Honourable Emmanuel Jime and replaced him with Mr. Akutah Pius Ukeyima

In the same vein, the president replaced the Managing Director of the National Inland Waterways Authority (NIWA), Dr. George Moghalu with Alhaji Munirudeen Bola Oyebamiji.

#### Oil Theft: Navy Deploys 10 Warships, Helicopters, BallisticBoats



he Nigerian Navy Service (NNS) says it has deployed 10 warships, two attack helicopters and 500 ballistic boats in a special amphibious exercise to curb crude oil theft and sea robbery in Nigeria's waters.

Flag Officer Commanding (FOC) Central Naval Command (CNC), Headquartered in Bayelsa, Rear Adm. Umar Chugali, disclosed this in Onne during a brief ceremony to flag off the exercise codenamed, "Exercise Sea Guardian".

Chugali said the joint military exercise

conducted by both the Navy's CNC and Eastern Naval Command (ENC), Calabar, was launched to reduce insecurity to its barest minimum in the nation's territorial waters.

"So, this joint exercise covering both the defence and the policy roles of the navy consists of 10 ships, two helicopters and over 500 boats for four days at sea.

"This exercise will be used to exercise and demonstrate the capacity and capability of our ships at sea, to secure Nigeria's maritime space and the Gulf of Guinea (GoG).

"Overtime, our maritime space has been inundated by some threats both onshore and offshore, hence this joint exercise that was last conducted in 2021", he said.

Chugali said the objective of the exercise was to ensure that the maritime environment remains safe, secured and conducive for socioeconomic activities to thrive.

"The deployment of our capital ships and other assets will complement the gains recorded in

curbing sea piracy, sea robbery, crude oil theft and other illegalities on our waters.

"Every operation presents new sets of challenges considering that security challenges in the maritime environment have become dynamic, emerging, and complex.

"So, with the emerging complexities in the waterways, the Navy is evolving its tactics and strategies to ensure that incecurity is to the barest minimum", he stated.

#### **AMATO Laments High Level Of Corruption In Cargo Delivery System At Ports**

he Association of Maritime Truck Owners (AMATO) has lamented a high level of corruption in the cargo value chain in Nigerian Ports.

Chairman of AMATO, Remi Ogungbemile, who made the allegation while playing host to the international anti- Corruption group, Siemens Integrity Initiative at the association's office Thursday, November 3rd, 2023, alleged that the existence of multiple checkpoints, extortion, slow terminals operations, touting and disunity in Customs operations often lead to confiscation of trucks after being duly cleared by Customs officials at the ports.

Siemens Internal Initiative has provided funding since 2010 to anticorruption agencies with the vision of ensuring a corruption-free environment for businesses and corporations around the world.

Through an external assessor, Nordic Consulting Group (NCG) Copenhagen, Siemens visited to assess the level of compliance with standard business processes and the impact of anti-corruption groups in combating the menace of corruption within the Nigerian port business environment.

Ogungbemi, who received the delegation along with members of AMATO and sister associations,

thanked the group for their unwavering effort in supporting the cause of the Nigerian port industry and truckers in particular to provide a platform for profitability and sustainability of the maritime transport business space.

On their part, Private Sector Development & Partnership Expert Nordic Consulting, Mrs. Marie-Louis Appelquist, and Evaluation and Governance Expert Nordic Consulting, Mrs. Ayla Olesen Yurtaslan, took note of issues raised by the truckers and promised to escalate to relevant authorities through the Maritime Anti-Corruption alliance MACN/CBI for responsive actions.

Speaking at the opening session recently, the Director General of NIMASA, Dr. Bashir Jamoh OFR, posited that the training would showcase the newest technologies, their application including cost-effective practices and related benefits for the environment and efficiency of shipping.

His words: "The importance of protecting and conserving our seas, oceans and their inhabitants cannot be overemphasized as we are intrinsically linked to them and their wellbeing reflects our own wellbeing too."

"Shipping is at the crux of global trading and the economy with about 90 percent of world trade and commerce is facilitated through shipping. Studies however, revealed that ships serve as over a time have channel for

"It was a significant moment in Guyana at the Africaribbean Trade and Investment Forum 2023 as we've secured a partnership with the African Export-Import Bank and Access Bank for a massive investment of \$1.352bn in Lagos.

"This investment will power our longterm infrastructure projects, demonstrating confidence from international and local partners in our growing economy," Sanwo-Olu said via his verified X (formerly Twitter) handle on Tuesday.

He noted that the investment will help the state to execute "key projects, including the Fourth Mainland Bridge,

Omu Creek Project, and the second Phase of the LRMT Blue Line from Mile 2 to Okokomaiko."

The governor added, "We're committed to creating a better future for Lagos and its people.

"Our vision for Lagos is becoming a reality with the Lekki-Epe International Airport and the Lagos Food Systems and Logistics Hub in Epe. These projects will further boost our economy and serve generations to come."

#### 'New MTS Centre To Accommodate 72,000 Seafarers Yearly'

## How I Started From Motorcycle To Vehicles-Innoson Chairman

Dr. Innocent Chukwuma, the Chairman and owner of Innoson Motor Vehicle company had a chat recently with some Auto journalists (including Transport Day), after his company marked 13th anniversary, in Nnewi, Anambra State

# Tell us some of the challenges since you started the auto manufacturing journey 13 years ago?

I would say the journey has been full of ups and downs, but we still managed to survive. Starting from when I was building this factory, a lot of challenges came up. Some people came to the factory and kidnapped the workers, including (Chinese) foreigners and Nigerians.

They took them away and started calling me. The second one was when GTBank wanted to shut down this place. Every Nigerian knows about it. I went to court and finally defeated them. GTBank is still owning me up to today. When we started, electricity was very poor even though it has improved now.

### What about the challenges of sourcing foreign exchange?

I am a manufacturer. We are in a better position than importers. This is because what we import is not everything we are using in the manufacturing of our vehicles. So we import a few items and use local materials to complete our needs. But, importers of ready made goods from overseas import 100 per cent, which means that their forex requirements are higher. So I can say that foreign exchange depends on a number of things; sometimes, you do some export and get foreign exchange. Government allocation of foreign exchange is no longer working.

#### How do you get your funding?

Normally, banks are supposed to be sponsoring businesses, but they are not sponsoring the industries. Nigerian banks are trading in foreign exchange. They are no longer sponsoring productive ventures, like manufacturing. They are trading from CBN to foreign exchange and they are not sponsoring industries. Any investor that relies entirely on banks will fail because the banks will even crush him.

Banks are not ready to support manufacturing. They can support people that import oil, but to support manufacturing, banks are not ready to wait, because manufacturing cannot bring that type of quick money they want on daily basis. We are trying to manage manufacturing very well, so that we don't need to borrow so much to manufacture because banks are not ready to sponsor it.



# What is the percentage of local content in your auto manufacturing, and how do you source them?

We source the items we use locally and we import some. We get all of them together. For example, we produce plastic components of the vehicles like bumper, dashboard, front grille, etc, at our Innoson Technical and Industrial Company Ltd, in Enene, Enugu. We are in a position to buy any item that anybody can produce locally. We don't need to import any of the items we can get in Nigeria. But we are still importing engine and gearboxes. The country they come from depends on the model we are doing. I don't produce tyres but when we need tyres we reach out to tyres dealers and tell them what we want.

# You made an attempt at tyre manufacturing many years ago. How did it go?

National Environmental Standards and Regulations Enforcement Agency (NESREA) said we cannot produce tyres because they did not authorise it. So we shut down, despite having invested a massive part of our resources in the project and imported some heavy equipment.

# Are you not disturbed that in these 13 years of existence, Nigeria had witnessed three Presidents and none of them has used IVM which is the practice in other vehicle producing nations?

I cannot say that our Presidents are not using my vehicles, because I have not checked their fleets. It is people that are

close to them that will check and find out. My vehicles are in the market and anybody can buy. I cannot say they are not using it. For instance, I never knew that the Lagos State Government was using my vehicles until someone told me.

# How did you get the seed money for this huge investment? Again, where do you get the steel? Also tell us the level of local components you are using.

The local content used in my vehicles are not less than 65 per cent. I will ask you one question to assist me: When I see you write so fast, how do you do it? I ask because I write very slowly. You are used to that. It will help me to answer your question. When you package your business very well, it will grow in a short time. Somebody who has grown a business for 40 years, that business is supposed to grow.

I started small, but grew it from a small business to what we have today. It is because of long practice. Somebody could groom you, but at a time, you grow by yourself. On steel, I don't produce steel, but I buy from steel dealers in Nigeria. When I need steel, I tell them the size I need and sometimes, they source it locally or from outside. We have a caliper to check the millimeter to confirm the gauge. If they are not up to the quality standard, we reject them.

#### How did you start? Tell us the journey into the auto business.

What I am doing today in auto manufacturing, I had earlier done in the

motorcycle industry and succeeded. The time I joined motorcycle business, there were five companies that were dealing in motorcycles: First was Leventis dealing in Honda; Yamako dealing in Yamaha; Bolous Enterprises dealing in Suzuki; and CFAO dealing in Kawasaki and Moblet. I brought Jianshe motorcycles which were under me. I studied what the big companies were doing. They were bringing 36 units fully built motorcycles in one 40-feet container. So with the 36 units in one 40ft container, they did all the expenses on the container and their cost was very high.

As a motorcycle expert, before I joined, I calculated the cost and expenditure. Then, motorcycle was N 150, 000 per unit, I calculated the component parts that make up one motorcycle and found out that the total cost was not up to N150, 000. So I decided to go and import the motorcycles in components (instead of ready-made). I listed the parts and brought them in, and used local technicians to assemble them in Nnewi. My container of motorcycle components, the same 40 feet size, could carry as much 150 units in one, instead of 36 units those companies were bringing in as fully built.

As a result, my own motorcycle price was lower than theirs and I sold the first consignment at N80,000 per motorcycle, while they were selling N150, 000. Clients tested it and found out that it was equally good. I did it for about five years like that without competition before others discovered what I was doing and joined.

As they were joining, I found another way of making it cheaper. I opened a plastic factory in Enugu to produce the plastic

components so that the price would be okay. When I started this component parts, some of them that joined started buying the component parts to sell their own. By then we had dropped the price of one motorcycle to N60, 000. From N150,000 to N60,000. Those who bought my plastic components were also selling N60,000, but those who were not

buying from me were selling higher. So, they bought my plastic and business was moving. That was when I said let me go into the automobile. Before I did it, people were only using second-hand motorcycles. What I did stopped the use of second hand (tokunbo) motorcycles, because the new motorcycles became cheaper than second-hand motorcycles. That was what chased tokunbo motorcycles away from the Nigerian market.

If you watch in Nigeria today, people are buying second hand vehicles. That was why I decided to go and develop the auto industry. If not for the foreign exchange issue, that is the weak naira against the US dollar at forex, people would have been buying new vehicles at cheaper prices in Nigeria now. For instance, I planned selling one of my Sports Utility Vehicles (SUVs) for N1 million for all to buy, but because of foreign exchange issue, the vehicle is going for N10 million now. People that import new vehicles cannot sell at our own price and that means we are still at an advantage.

#### What are your plans for motorsports?

Nigeria is big with a large market. My focus is to conquer the motor needs of people in Nigeria and beyond. The people that are doing motorsports in other places have conquered this for a long time before they joined motorsports. I will join that when I conquer the people's needs in Nigeria.

Do you have the facility to test vehicles and what is your daily or annual production capacity?

We have the facility to test vehicles. We

have that section. I do 50,000 units and with what we are building in our factory is to produce 60,000 units annually if there is demand. We don't produce and keep because of where to keep them. But we have an installed capacity that can handle the production, if there is need. When there is demand we open up the production line and employ more people. When you are producing like 10 vehicles a day; when there is demand, you can make those 10 vehicles to 100 vehicles per day. What you do is to add workers times 10. Then what will take you one hour to do, you will do it in 10 minutes. We have the capacity to produce 60,000 if there is need.

What capacity do you have in terms of conversion of vehicles to CNG and what advantage does CNG have over other types of fuel powered vehicles?

We can do conversion. Government said they brought in conversion kits, but I don't know how or what they imported. I convert for people

## What are your views about the automotive industry in Nigeria?

My view is that if everybody supports the automotive policy, it will go well. The Automotive industry is the way forward and I want Nigeria to be leading the industry in Africa.

You were approached by Abia state government to supply some vehicles. Suddenly, we heard that you could not get those vehicles ready within the period the government wanted it and that was why it went to another company. Can you shed more light on that?

What happened was that they needed 100

vehicles and I supplied 80. I told them that the remaining 20 would be ready in 14 days, but they said they needed it immediately. Then I told them they could buy from shops. I am a manufacturer and not a trader. They said they needed the 20 units immediately; that it was for security. I went to them to tell them like that so that people will understand. The

governor is one of my best friends, even before he became a governor. He doesn't joke with my products and that is why if you go to Abia state today, you will see my vehicles everywhere. Even the governor himself is using my vehicles.

#### You also have issues with Imo State Government. Has it been resolved?

No it hasn't been resolved. They just seized the money for almost three years now. The amount is N2.6 billion for 150 vehicles I supplied to them. Today, the money has gone up to N7 billion. I am in the court with them.

The vision of Innoson is to conquer the

Nigerian and African market. How much have you been able to export your products to other African countries?

I have got up to 15 contracts from different countries outside Nigeria. The reason we don't export from Nigeria to other African countries as often as we want is because Africa does not have shipping lines that go round the continent. Sometimes, when you export to Ghana, the vessel will first carry the containers to Europe before going to Ghana. But if we have shipping lines that go round Africa, Africa has a lot of things that they can export to each other. But if you watch, getting something from other

African countries is difficult. Unless you go to Cotonou to carry it, it is easy to come in. If African countries want inter-Africa trade to grow, they should have shipping lines going round Africa. Without that, trading among African countries will be difficult.

Meanwhile, I tried to service the 15 contracts but I found out what their problems were, which is unavailability of shipping lines to carry the consignments for them. When they run into that difficulty today, they would not come back to you tomorrow. For instance, some of the countries I have exported vehicles to, include: Ghana, Sierra Leone, Senegal and others.

What encouraged you to look homewards in terms of locating your assembly plant in Nnewi?

It is not that I looked home-wards. The fact is that I don't like crowds. I think I like where traffic will not be holding me on the road so much. That was why I decided to be here in Nnewi and Enugu. Other places like Lagos and Onitsha are filled up. So I came down to Nnewi so that it would be easy for me to coordinate. Right now, I have two factories in Nnewi and accessing them is very easy for me. But if it is in Surulere or Apapa in Lagos, will you go? After all, market is everywhere.

## What is the secret of business success of Nnewi people?

Nnewi people, starting from origin have the keys of business. Remember the late



Louis Odumegwu Ojukwu, who was the leader in Nigeria even before the war. Most of our people are business people and they are used to business. Each town has something unique to them and in the case of Nnewi business is their uniqueness.

# Where will Innoson be in the next 10 years, now that you have celebrated 13 years of existence?

I believe that in the next 13 years, Innoson will be everywhere in Africa.

What are your succession plans?

It doesn't mean that I am the one doing all the job. People are doing it. And those that are doing the job are younger than me. We rewarded some of the people that started with us at our 13th anniversary event today, because they are very important in our business. They stayed with us for a

long time and we gave out 15 motorcycles to them. I sent our factory manager to China and trained him for eight years. Besides, they are all my friends and we eat at the same table. They love me and they cannot harm me.

## Can you tell us something about the new factory in Umuezena, Nnewi?

That place is 400, 000 square-meter land space. One of the buildings I am putting up there is 40, 000 square meters. There will be three factory buildings, which brings the total to 120,000 square meters.

### Which of the IVM models is the fastest selling in your line-up?

Vehicles are like a fashion items. This year, vehicle B can be the fastest selling, next year vehicle D will come up. We produce all to sell. You cannot say this is the fastest. Three things determine the fastness: One is the price, number two is usage, and number three is the utility. Like buses and pickups which are tailored for commercial use. All of them are doing very well. However, what we do is that anyone that is not doing well, we stop it and replace it with another model. That is why I am manufacturing.

#### What are the advantages of. Compressed Natural Gas, CNGpowered vehicles?

President Tinubu has done Nigeria good by removing subsidy and introducing CNG. Any day, people understand what CNG is, they will be happy with the government. I started the production of CNG for the past two years, long before it was formally introduced following the removal of oil subsidy on May 29 by the President. As at the time the government announced the removal of subsidy on petrol and the talk about CNG as an alternative commenced, I already have up to 100 units of vehicles running on CNG on ground; parked here in the factory. It happened that way because I knew that one day, subsidy would be removed. I have vehicles that are powered by CNG in all the IVM models, and I also convert for people who are driving Innoson. I want to give them the advantage first because they are my customers.

## Reps To Probe Hike In International Flights Fares



he House of Representatives has mandated its committee on aviation to investigate the hike in international flight fares and poor service delivery by foreign airlines operating in Nigeria.

The House resolution followed the adoption of a motion, titled "Need to Curtail Exorbitant Airfares by International Airlines in Nigeria" moved by Moshood Olarewaju Oshun. Moving the motion, Oshun noted that the Nigerian Civil Aviation Authority, NCAA, reported that as of 2022, 16 international airlines were operating in Nigeria.

He also noted that in 2023, international passengers' traffic had grown massively from the 3,503,692 that was recorded in 2022, and had continued to grow rapidly, especially with outbound international travellers. According to him, the international airlines are taking undue advantage of the surge in international passengers' traffic to charge exorbitantly for flights and cashing out on Nigeria.

The lawmaker further explained that compared to other West African countries, such as Ghana, Benin Republic, and Niger Republic, the rates set by international airlines operating in Nigeria were outrageous, despite poor service delivery and use of old aircraft by the airlines, against what was obtainable in other countries.

He said Turkish Airlines charges as much as \$3,538 (N2.7million), with

the lowest advertised fare being \$1,432 (N1.1 million) for a Lagos-London flight, whereas the same airline charges between \$475 (N368,837) and \$601 (N466,676) for a London-bound flight from Cotonou, which is a huge and unfair contrast to what people were forced to pay in

Nigeria.

He expressed worry that other international airlines operating in Nigeria were guilty of this unfair hike in flight fares for inbound and outbound international flights, which puts Nigeria at a disadvantage economically.

# IATA Insists On Net Zero Carbon Emission By 2050

he International Air Transport Association (IATA) has said there is no going back on the zero-emission target by 2050. The clearing house for over 280 world airlines said every drop of fuel avoided counts in the aviation industry's quest to achieve net zero carbon emissions by 2050, especially with the latest result from the IATA Fuel Efficiency Gap Analysis (FEGA).

According to IATA, LOT Polish Airlines (LOT) is one of the airlines to undertake the FEGA, which identified the potential to shave its annual fuel consumption by several per cent. That equates to an annual reduction of tens of thousands of tonnes of carbon from LOT's operations.

IATA's Senior Vice President of Sustainability and Chief Economist,

Marie Owens Thomsen, said every drop counts. Thomsen said: "Since its inception in 2005, FEGA has helped airlines identify cumulative savings of 15.2 million tonnes of carbon by cutting fuel consumption by 4.76 million tonnes.

"LOT is the latest example of an airline exploring all opportunities to achieve every incremental efficiency possible in fuel consumption. That's good for the environment and for the bottom line."

On average, FEGA has identified fuel savings of 4.4 per cent per airline audited. If fully realised across all audited airlines, these savings, which stem primarily from flight operations and dispatch, equate to removing 3.4 million fuel-powered cars from the road.

#### NASA Completes Key Step in Aviation Safety Research

ASA's a eronautical innovators have completed a significant step in their pursuit of safer, more efficient aviation technologies that spot hazards before they occur.

Through its System-Wide Safety project, NASA and its partners in government, industry, and academia are exploring new technologies and techniques to improve current aviation safety and potentially enable widespread use of new types of aircraft such as drones or air taxis.

The project recently completed

Technical Challenge 1 (TC-1), Terminal Area Risk Management, the first step towards achieving what is known as an In-Time Aviation Safety Management System. This new type of aviation safety technology can effectively address potential hazards expected with the rise in demand for the number and types of aircraft flying in the National Airspace System.

As aviation operations continue to grow in scale and diversity, and with new modes of flight

expected to rise in the near future, keeping the skies safe becomes increasingly complex and drives the need to transform the way order is maintained above our communities.

"What we've accomplished with TC-1 is really just beginning to scratch the surface of what's possible," said Kyle Ellis, NASA's project manager for System-Wide Safety. "Developing these systems enables a new economy for aviation uses that will benefit us all in the future."

Planning Ahead

In a busy aviation environment, an In-Time Aviation Safety Management System can efficiently identify and predict safety issues a human would be hard tasked to keep up with. In today's airspace safety system, let's say an air traffic manager is looking at their screen and guiding 10 airplanes towards their destinations. This person would use a combination of established safety rules and pattern recognition to make sure those aircraft remain a safe distance apart. If this person saw a hazard that posed a safety risk, they would work with the pilots aboard the aircraft and resolve the issue.

Now, let's think about the airspace of tomorrow. Instead of 10 airplanes total, 10 air taxis, 10 ultra-efficient airliners,



and 10 commercial supersonic jets might be sharing the same confined airspace. Preventing and addressing hazards would become a more complex issue nearly impossible for a person to identify in time to prevent an accident.

An In-Time Aviation Safety Management System is designed to identify these events much more rapidly than human operators, then quickly deliver actionable safety procedures to prevent the dangerous situation long before it develops.

Furthermore, preventing these situations from ever arising in the first place increases the efficiency of the airspace overall, since not as much time and effort would be spent by managers keeping things running

smoothly.

Laying the Foundation

TC-1 contributed several important pieces of technology working towards the development of such a system. These contributions improve aviation safety not just for tomorrow but also for today.

For example, part of the research included using new machine learning algorithms to analyze data gathered from major airlines, which use existing aviation safety management systems, to discover potential safety risks that had previously been undefined overall making things safer.

Researchers also gathered information on exact ways human safety managers, pilots, air traffic controllers, and others interact with safety procedures. The team identified useful, efficient practices, as well as those that could potentially lead to safety risks. Their work contributes substantially to improving training and safety operations.

Additionally, researchers studied human performance and fatigue, partnering with pilots to study

how various factors such as flight scheduling, certain short-haul routes, and even the COVID-19 pandemic affect operations.

Other results include prototype safety tools and surveys on human performance.

With this more comprehensive understanding of the safety landscape, NASA and its partners can more effectively continue ushering in new safety technologies.

"We focused on gathering data on current-day operations, but always have an eye for the near future," said Nikunj Oza, subproject manager for TC-1. "We can use the lessons learned about current aviation safety to best inform new systems."

#### G7 Launches \$600bn Trans-African Railway To Counter China's Belt And Road

he US and the EU have joined forces with the African Development Bank (AFDB) and the Africa Finance Corporation to launch the west's latest attempt to counter China's Belt and Road Initiative.

The parties have signed a memorandum of understanding setting out plans to develop the "Lobito Corridor" and the ZambiaLobito railway, which will together form a link across Africa through a number of large mineral deposits.

The deal was done on the margins of the Global Gateway Forum in Brussels, an invitation-only meeting of EU governments with companies, banks, and international organisations intended to promote international infrastructure.

The State Department said in a press statement that the project was "the most significant transport infrastructure that the US has helped develop on the African continent in a generation, and will enhance regional trade and growth as well as advance the shared vision of connected, openaccess rail from the Atlantic Ocean to the Indian Ocean".

The projects will be carried out under the auspices of the Partnership for Global Infrastructure and Investment, the G7's response to the BRI, launched in June last year at the Schloss Elmau summit in Germany. The idea is to invest over \$600bn by 2027 to close infrastructure gaps around the world.

The US and its allies have tried before to launch schemes to compete with Chinese infrastructure largesse in the developing world.

In 2013, then president Barack Obama launched his "Power Africa" initiative aimed at investing \$7bn to add more than 10,000 megawatts of clean electricity. It fizzled out.

The G7 tried again in June 2021 with its "Build Back Better World" scheme, intended to funnel billions into



infrastructure in Latin America, the Caribbean, Africa, and the Indo-Pacific.

The latest version is more targeted.

Helaina Matza, the special coordinator of the partnership, said in a digital press briefing that the idea was to finance rail refurbishment from the Angolan port of Lobito to the border with the Democratic Republic of Congo (DRC).

A new railway from northwest Zambia would join that line.

She said the aim was to "demonstrate collectively, together, that you can invest, and you can invest in large-scale infrastructure. And ... this consortium is a great example of that.

"It's 800km of new greenfield rail cutting between Angola and Zambia. It involves a large contribution from AFDB that they're sorting out the parameters. And collectively, all funding partners put together around \$10m to start the feasibility study before the end of this year."

The project also involves building 260km of roads and about 550km of track in Zambia, spanning from the Jimbe border to Chingola in the country's copper region.

As well as the railway, the corridor will involve 4G and later 5G telecoms systems and a billion-dollar investment in solar farms and

microgrids.

South African broadcaster News24 notes that the US and the EU have adopted a scheme that was already under way.

In July this year, Zambia, the DRC, and Angola signed their own memorandum of understanding on progressing the corridor. A consortium led by multinational commodities trader Trafigura had already been appointed to run a \$570 m rehabilitation scheme.

Ms Matza said: "When we found the opportunity to support the work that the DRC Government, the Angolan Government, and the Zambian government had already decided they wanted to do in their tripartite agreement, which they very serendipitously signed on 4 July this year, we wanted to make sure we were doing everything we could to help with those efforts."

News24 commented: "This is a direct challenge to China's BRI, largely viewed as an unsettling extension of China's rising power.

"However, it will be impossible to avoid working with China on the Lobito project since Mota-Engil, partly owned by China Communications, signed an agreement to run the Lobito Corridor as part of the Trafigura consortium."

#### AfCFTA: Dismantle Multiple Checkpoints Now, NAFFAC Tells FG



## African Continental Free Trade Area (AfCFTA)

he National Association of Freight Forwarders and Consolidators (NAFFAC) has cautioned the federal government against multiple checkpoints along the Lagos-Badagry corridor and other entry points across the six geopolitical zones to encourage Nigeria participation in the Africa Continental Free Trade Area (AFCFTA) Agreement.

NAFFAC lamented that Nigeria businesses may suffer major setbacks if government fails to resolve the bottlenecks on the movement of goods from the entry points and international frontiers saying that Nigeria goods and services have potentials to compete favourably in the region.

Speaking at a roundabout meeting put together by the Association of Maritime Journalists of Nigeria (AMJON) recently in Lagos, President General of the foremost freight forwarding group, Prince Adeyinka Bakare expressed concerns over the multiple checkpoints manned by security agencies and touts, noting that the illegalities would further affect foreign and local investment.

Bakare stated that the association has engaged government at all levels in furtherance to tackling the illegalities along the Lagos Abidjan corridor.

According to him, there are only five checkpoints between Ghana and Benin noting however that Nigeria has over 30 checkpoints manned by operatives of the government which he described as extortion of the highest order.

Bakare who doubles as the Managing Director, De Potter Nigeria Limited, told the group of journalists that trade barrier must be eliminated for the country to participate fully in AFCFTA, calling on the president Bola Ahmed Tinubu led administration to reduce the number of checkpoints along the routes to encourage international trade.

The NAFFAC boss explained that Nigeria stand a chance to benefit immensely in the exportation of her commodities to other countries of the continent if well harnessed.

While reiterating the association's commitment towards encouraging exportation, Bakare explained freight forwarding business is beyond import, urging government to look inward to put in place policies to drive export.

He lamented that the poor foreign exchange rates against the Naira has also discouraged international trade but expressed optimism that non -oil export would further grow the economy when government prioritize cargo exportation.

"Government needs to listen to this call because all our export supposed to be on CIF which is Cost Insurance and Freight and not the other way round.

"The issue of multiple checkpoints along the entry points is killing the business and it will affect the AFCFTA. The multiple checkpoints is not limited to Lagos Abidjan corridor alone. It is common in the northern region of the country and government is not doing anything about it".

# **Lagos Affirms Commitment To Investment In Smart Transportation Solutions**

## FEMADEC, Others To Construct CNG Conversion Kits

EMADEC Energy Group among others, under the Presidential CNG Initiative (P-CNGi) have announced plans to establish over 1,000 Compressed Natural Gas (CNG) conversion centers across Nigeria. The move aims to make CNG more affordable and accessible to Nigerians.

The first conversion centre was inaugurated in Lagos, where the Chief Executive Officer of FEMADEC Energy Group, Fola Akinola, explained that the initiative seeks to reduce CNG prices. Akinola stated: "What we are kicking off in Lagos is

not the end. We have another one in Lagos State coming up, we have one in Ogun State coming, Port Harcourt scheme will be launched soon, Abuja is coming very soon, Kaduna and many more are also coming up."

Akinola emphasised that the country



spends a substantial amount importing fuel and encouraged a shift to CNG, which is safer, cleaner, and will be made affordable. "We are going to produce our own CNG... I want to promise Nigerians with the help of P-CNGi and MOFI, we will maintain a cost not exceeding N250 for CNG," he added.

P-CNGi CEO, Michael Oluwagbemi, highlighted the safety of autogas and assured that CNG is different from LPG. He said, "CNG is confined in a 10-millimeter steel cylinder. It is bulletproof... so the likelihood of an explosion is next to nil." He added that the initiative would leverage 55,000 conversion kits in the coming months and emphasized the economical benefits of transitioning to CNG.

CEO of Mofi, Dr. Armstrong Takaang, expressed gratitude to the President for his support and

highlighted Nigeria's potential as a gas nation. "It is much cleaner to use the CNG, and that is why the launch of this program, particularly the conversion workshop, is key for us. It marks a major milestone in this program," he said

## FG launches CNG Conversion Centre In Abuja

he Federal Government of Nigeria has officially commissioned a pilot conversion centre for vehicles that will run on compressed natural gas in the Federal Capital Territory.

It said the centre will boost the CNG initiative of the government and mitigate the effect of subsidy removal on petrol by reducing transportation costs.

This was disclosed in a statement signed by the Transport Ministry, Director, Press and Public Relations, Olujimi Oyetomi on Friday.

The Minister of Transportation, Said Alkali, speaking at the ceremony, revealed that the adoption of a more environmentally friendly energy source like the CNG would help reposition the transportation sector.

The minister, who was represented by the Acting Director, Road Transport and Mass Transit Administration, Akhidenor Cynthia, said greenhouse gas emissions pose a health hazard and dire environmental consequences, and the country must play its role in reducing carbon emissions in the environment.

He said, "The adoption of a more environmentally friendly energy source like the CNG, which the country has in abundance will reposition the transportation sector in urban cities across the country and put Nigeria in tandem with what the world desires at this time."

On her part, the Permanent Secretary, Federal Ministry of Transportation/Marine and Blue

Economy, Dr. Magdalene Ajani urged Nigerians to consider the conversion of vehicles to CNG as a symbol of a new beginning, adding that the CNG initiative is not only about the conversion of vehicles but also about generating employment opportunities. According to Ajani, the goal is to build a sustainable future, leveraging our own cheap and clean energy source.

Also speaking at the inauguration, the Chief Executive Officer of the Presidential Compressed Natural Gas Initiative Steering Committee, Micheal Oluwagbemi, described the adoption of CNG as a significant development in diversifying the transportation sector from fuel dependency to natural gas.

## \$600b Needed Yearly For Grid Development-IEA

he International Energy Agency (IEA) has announced that an investment of \$600 billion must be injected yearly into the development of energy grids worldwide to prevent gridlock, as highlighted in a recent report. This is coming at a time when Nigeria's electricity grid is experiencing significant challenges, with frequent collapses impeding supply.

According to the IEA's report, titled: "Electricity Grids and Secure Energy Transitions," the world requires substantial changes to the grid to achieve net-zero targets. It emphasised that reaching these targets necessitates the addition or replacement of 80 million kilometers of power lines by 2040, a figure equivalent to the entire existing global grid.

International Energy Agency

report indicates that to achieve countries' national energy and climate goals, the world's electricity needs must grow 20 per cent faster in the next decade than it did in the previous one.

It also highlighted that global grid expansions and upgrades are not keeping pace with the rapid growth of clean energy technologies, such as solar, wind, electric cars, and heat pumps.

"Without greater policy attention and investment, shortfalls in the reach and quality of

grid infrastructure could make the goal of limiting global warming to 1.5 °C unattainable and undermine energy security," the agency stated.

# Qualities of a Good Engine Lubricant

#### Viscosity

When any lubricant offers resistance to the deforming forces, it is called the viscosity of the lubricant. Good quality lubrication oil must maintain sufficient viscosity at higher temperatures and it should not be too viscous at lower temperatures.

For high speeds, low viscosity lubricants are suggested while for large clearance and high loads; high viscosity lubricants are recommended. The viscosity of oil increases, if the temperature of mating surfaces decreases.

#### Flash Point & Fire Point

The Flashpoint of oil is the minimum temperature at which it gives off enough vapor to form a momentary flash when the naked flame is brought near its surface, while the fire point is the lowest temperature of the lubrication oil, where it burns continuously.

To avoid the possibility of fire, the flashpoint of oil must be higher than

the temperatures likely to be developed on the rubbing surfaces

The fire point is generally higher than the flashpoint and the difference between the flash point and fire point must be 18-degree centigrade on the higher side.

#### **Oiliness**

It is the property of lubrication oil to spread and attach itself firmly to the lubricating surfaces. When mating surfaces are subjected to high intensity of pressure, it is recommended to particularly high oiliness; so that the metal is protected by a layer of oil and the wear is reduced.

#### **Volatility**

Lubrication oil losses a certain weight due to evaporation when it is subjected to high temperatures for long hours. This loss is known as "loss by evaporation".

The consumption of oil is considerably increased with high volatility at normal working temperatures which is why low volatility is always suggested for lubricants.

#### Stability & Insoluble Residue

The stability of the oil is to resist oxidation that would yield acids and sludge. Good lubrication oil must have high stability.

Free carbon or hydrocarbons decomposing into carbon at high temperatures is called the insoluble residue. Good quality lubrication oil should not have any insoluble residue.

"About three years ago, we commenced the construction of four bridges across rail lines between Oyingbo and Ikeja. The bridges, located at Ikeja, Mushin, Yaba and Oyingbo, are designed to ensure the safety of our people.

"Over the years, we have recorded avoidable fatal accidents on railway

crossings, most of the time due to human errors.

"The ceremony is therefore significant because with this Overpass Bridge and others at Ikeja, Mushin and Oyingbo which will be formally commissioned before the end of the year, there will be no more occurrence of train-vehicular accidents at these locations.

"Without any iota of doubt, we have remained focused on our commitment to developing sustainable solutions to the transportation challenges along the major transit spines to give relief to our teeming population by reducing congestion, and improve travel time as well as the cost of commuting."

On the award of the second phase of the Mile 2-Okokomaiko Blue Line, the governor said: "I have also signed the contract for the second phase of the Blue Line from Mile 2 to Okokomaiko. Construction has started and is expected to be completed in three years. We have given the contractor a deadline for the completion.

Meanwhile, the Governor only recently also commissioned the Oyingbo overpass.

#### FEC Okays N5.9bn For Abuja Light Rail Access Roads

he Federal Executive Council (FEC) has approved N5.9 billion for the construction of access roads for the light rail system in Abuja.

The Minister of the Federal Capital Territory (FCT), Nyesom Wike, made this known recently while briefing newsmen on the outcome of the weekly FEC meeting presided over by President Bola Tinubu at the State House, Abuja.

According to him, the president has set a timeline for the completion of the Abuja light rail project, emphasizing the importance of addressing the roads that connect to the railway.

The Minister of Information and National Orientation, Mohammed Idris, who disclosed this to newsmen after the FEC meeting recently, stated that ministers, special advisers and other top government officials are expected to be in attendance.

President Tinubu had on August 21, 2023 inaugurated 45 ministers, while on October 16, he administered oath of office on three more ministers to make it a 48-man cabinet.

## **RAILWAY**

#### NRC's E-ticketing Commences For Lagos-Ibadan, Itakpe-Warri Routes

he Federal Government has launched the E-ticket platform for Lagos-Ibadan and Warri-Itakpe rail lines.

The Minister of Transportation, Saidu Alkali, speaking at the official launch of the E-ticketing platform held at the ministry headquarters recently in Abuja, said the government is ready to improve its revenue by utilising all internally generated revenue through technology channels available to it.

He said the platform was launched to improve access to transportation services, end

ticket racketeering and eliminate revenue leakage.

The e-ticketing platform took effect from November 1st, 2023 and can be accessed via https://nrc.tps.ng.

The minister said, "The essence of Eticketing is to make it easy for our passengers to buy tickets, for security purposes and to stop ticket racketeering. it will also ensure the security of our passengers onboard the train and avoid racketeering.

"From Wednesday, November 1st, Nigerians will enjoy the benefit of buying tickets at their own convenience and without any issues." On his part, the Managing Director of the Nigerian Railway Corporation, Fidet Okharia, stated that the initiative had increased its weekly revenue on the Warri-Itakpe route to N28 million.

"I am so happy about this project, apart from the fact that e-ticketing will end issues of ticket racketeering, it will also increase the revenue from the routes. This means by the time e-ticketing commences, there is a likelihood that our revenue will increase.

"I can also announce that for the fear of the e-ticketing coming, we can see our revenue growing. I can boldly say that



throughout last week, we didn't earn anything less than N4m a day on the Itakpe Warri route,"

"I am certain that with this launch, I will stop receiving calls on why my staff are cheating Nigerians," he stated.

The NRC DG restating his commitment to end unethical practices revealed that 14 persons have been heavily sanctioned for ticket racketeering.

#### Railway Workers Kick Against Ajaero's Assault

he Nigerian Railway Workers under the auspices of Nigeria Union of Railway Workers (NUR) has condemned the alleged kidnap and assault on Comrade Joe Ajaero, the President of Nigeria Labour Congress (NLC) by Imo State Government.

The workers have however called on the Federal, Imo State governments and the Imo State Police Command to unravel all the sponsored thugs that perpetrated the attack against Ajaero and other workers in the state.

A statement by Comrade Segun Esan, the Secretary General, NUR recently, described the attack on Ajaero and other union leaders by the State Government as travesty of justice, rationality and democratic ethos, which must not be allowed to stand in a sane society.

The union insisted that the gathering by

the workers for the purpose of peacefully protesting against acts of injustice was a legitimate right that does not in any way contravene any known law or the constitution of Nigeria, especially when all due diligence had been followed and wondered the heinous attack on the union leaders.

Esan declared that the attack on Ajaero was a pre-determined one and must not be allowed to go uninvestigated.

He said: "It therefore constitutes and arrant travesty of justice, rationality and democratic ethos for any person or group of persons, no matter how highly placed, to violate the fundamental human rights and collective sensibilities of the Nigerian workers by kidnapping, assaulting and eventually detaining Comrade Joe Ajaero in material particular and other law abiding Nigerian workers in general.

## UNIONS, ASSOCIATIONS

#### Understaffing Affecting Delay In Lilypond Clearance, MWUN Allege

embers of the Maritime Workers
Union of Nigeria
(MWUN) have highlighted the understaffing issues faced by shipping companies operating at the Lillypond Export Processing Terminal, which, according to them, are causing delays in the clearance procedure.

They made this known when the Lilypond Export Command of the Nigerian Customs Service (NCS) held a Press briefing recently,

where they revealed their role in facilitating 12,438 export containers with a total Free On Board (FOB) value of \$518,690,852.93 between January and September 2023.

Comptroller Ajibola Odusanya, the Customs Area Controller of Lilypond Export Command, described the Command as a one-stop shop for export business. He explained the government policy in Nigeria, stating, "The current government policy in Nigeria requires zero duty payment for exports. Exporters generally do not pay export duties, except in special cases



where goods that were initially imported and are being re-exported pay a 2.5 percent levy based on the current value of the goods with government permission."

Comptroller Odusanya further provided a detailed breakdown of the exports facilitated by the Command during the year, including 6,524 20-foot containers and 5,914 40-foot containers, all with an FOB value of \$518,690,852.93.

The goods exported range from agricultural produce such as cocoa, cashew, soya, ginger, hibiscus flower (zobo leaves), cotton, and sesame

seeds to locally manufactured goods like cigarettes, cosmetic items, beverages, and solid minerals such as aluminum, copper, magnesium, lithium, and zinc. The Command also handles various other commodities, including foodstuff and personal effects.

Stakeholders present at the briefing expressed their satisfaction with the efficiency of Customs officers in processing documents but emphasised the need for more manpower from other government agencies stationed at the export terminal to streamline clearance processes.

#### Fast-track CNG Vehicles To Ease Hardship, NURTW Begs FG

he National Union of Road Transport Workers has urged the Federal Government to fasttrack the introduction of Compressed Natural Gas-powered buses. The union stated that an adequate implementation of the scheme would cushion the effect of the removal of subsidy.

President Bola Tinubu in July promised to acquire and distribute 3,000 CNGfuelled buses across the states and local governments for mass transit at an affordable rate.

Also, the Minister of Finance and Coordinating Minister of the Economy, Wale Edun, in a statement recently, said with the introduction of the CNG vehicles, Nigerians would pay less for transportation.

Factional NURTW spokesman, Segun Falade, said though the 3,000 vehicles were far less than the population, the government should hasten the process of making them available.

He said, "CNG buses are alternatives that can help ease the effect of the subsidy removal especially as it relates to the current cost of fuel against the CNG.

"What the government should do is that they should try and hasten the processes towards getting the buses. They said they want to acquire 3,000 buses nationwide, which is a far cry from the number of passengers all over Nigeria.
