Using the Re-circulation Button In The Car

ost vehicles have a recirculation button with the AC controls in their cars. But many of are unsure when to use it. In Europe and the West, the easy answer would be to use it in the summer and turn it off in the winter. However, in Nigeria, it will be very useful whenever you turn on your AC.

The recirculation button simply takes the air from inside the car and recirculates it in the cabin instead of pulling fresh air from outside. On days like today when it is miserably hot outside, if you do not recirculate the cooler air in the cabin, than your AC system is pulling hot air from outside and trying to cool it. Using the



recirculation feature will get your car cooler and will decrease the wear and tear on your AC system.

- Side note, if your car has been baking in the sun, it's better to roll the windows down and turn recirculate off for the first minute or so to get rid of the superhot air inside the car before turning the recirculate on.

Also, any time you are stuck in traffic (summer or winter) be sure to use the recirculate. If you are pulling air from outside, then you are pulling in all the pollutants and carbon monoxide from all the traffic. Studies show that recirculating your AC can cut down on the pollutants entering your vehicle by 20% when stuck in traffic!

Lagos Trains Over 309 LASTMA Officers

Moving Cargo With Rail From The Ports

recisely on June 10, 2021, then President Muhammadu Buhari, commissioned the \$1.5b Lagos-Ibadan standard gauge railway line. The line, which is meant to eventually get to Kano from Ibadan, is to move both passengers and freight. Shortly after the commissioning, the line commenced passenger

movement, and many who have used the line, do not hesitate to praise the federal government for the laudable project.

However, three years down the line, the freight service which the same line is supposed to offer, remains uncertain. Initially, this was not unconnected with the fact that government needed to tidy up the line linking the ports to the Ebute-Metta terminal.

After all the initial hiccups were cleared, on September 12, 2023, the newly appointed Minister of Transport, Saidu Alkali, inaugurated the first cargo movement from the Lagos-Ibadan rail corridor during his first official tour of the rail corridor. Three coaches of 30 wagons were loaded as the inaugural freight movement was kicked off.

Managing Director of the Nigerian Railway Corporation, Engr. Fidet Okhiria, thereafter, said it would start with three coaches per day, noting that the corporation had the capacity to scale up the numbers.

It is expected to decongest the Apapa port.

But this is yet to be. The Managing Director of Inland Containers Nigeria Limited (ICNL), Ismail Yusuf, recently told journalists that "In 2023, when we moved about 15,000 containers, we were supposed to move them by rail but unfortunately, the rail didn't work at all. We moved those containers by road and we eventually paid both Kaduna and Kano cost of transportation to our transporters, which was about N72 billion.

"Our breakdown shows that about N48 billion was spent to move

containers to Kano and N24 billion to Kaduna," he said.

On why potential users are still opting for trucks, the NRC MD explained that "The terminals are charging N60,000 per container for moving the container through wagon freight, which is still higher than the movement on trucks, and the Shippers' Council is working on that. The terminal charges are high because of the double handling; presently, moving cargo by rail is more expensive than road but is faster."

It is very important that the issues are quickly looked into by the different government agencies concerned in order to maximize the usage of the rail lines, considering the huge investments put into it.

Safeguarding Flyover Bridges In Lagos

t costs billions of Naira to construct bridges. They are essential parts of the much needed transport infrastructure. They keep road traffic flowing and ultimately save time and man hour on the roads.

Hence, we cannot undermine the invaluable contributions these bridges make in ensuring that the free flow of traffic is maintained and sustained.

However, these bridges have over the years become endangered because of the abuse they have been subjected to by heavy duty vehicles, vandals and illegal squatters under the bridges.

It would be recalled that last year, the federal government directed the immediate closure of the Ijora-Olopa Bridge in Lagos following the discovery that some miscreants have tampered with the major reinforcement elements of the deck from underneath, which led to the failure of a section of the Bridge.

In 2022, there was fire outbreak under the Apangbon bridge also in Lagos which affected the bridge, leading to its closure for about one year. It was suspected that the fire must have emanated from shops built under the bridge.

Director of Lagos State Fire and Rescue Service, Adeseye Margaret, who described the nature of the fire as "disastrous", added that "the intensity of the fire has badly affected the Eko bridge truncating movement along that corridor."

It is also common to see heavy duty trucks, especially those on queue to lift cargo from the Apapa ports, or the tank farms, permanently stationed on bridges in Lagos.

The state government has been battling over the years to ensure that the bridges remain safe. Only recently, it destroyed illegal shanties occupied by squatters under the Ijora Causeway Bridge.

The government had earlier given a five-day quit notice to squatters

under the bridge and the Lagos Blue rail Line overhead bridge in Ijora to remove all their shanties for constituting a danger to the Lagos Blue Line corridor or risk demolition and removal.

But the government needs to up its game. Our observation is that many persons, artisans and traders use the bridges illegally, constituting potential dangers to them. Permanent seal up of under of these bridges may be considered, as well as prosecution of persons found to be violating the law. Government should also use materials that cannot be easily vandalized when building bridges.

The state government should be firm in ensuring that these bridges remain safe as it takes so much money to repair.

Though Lagos is the focus, we have also observed that many other cities are facing some similar challenges, though not at same magnitude in Lagos.

When to Change Your Tyres:

1. Tread Depth: The tread depth of a tyre is a key indicator of its condition, the legal minimum tread depth varies from country to country, but it is commonly 1.6 mm, but it is advisable to replace tyres before they reach this limit. A common recommendation is to replace tyres when the tread depth is around 2 mm to maintain optimal grip, especially during wet seasons.

2. Age of Tyres: Tyres also age, even if they have sufficient tread. The harsh climatic conditions, such as high temperatures, can accelerate the aging process. As a general rule of thumb, consider replacing tyres that are six years old, regardless of their tread depth.

3. Visible Signs of Wear: Inspect your tyres regularly for visible signs of wear, such as bulges, cuts or uneven wear patterns. If you notice any of these issues, it's an indication that the tyre may be compromised and should be replaced promptly.

4. Performance Issues: If you experience a decline in your vehicle's



handling, braking efficiency or notice vibrations, it could be a sign that your tyres need replacement. Don't ignore

these warning signs, as they can jeopardise your safety on the road.

Freee: Turning Tyres Into Tiles And Bricks

rigerian company, Free e e Recycle is reducing landfill by turning old tyres into new products, sold across the country.

According to a report by the Tyre Industry Project, one billion end-of-life tyres are generated globally every year. And an estimated four billion are currently in landfills and stockpiles worldwide.

But in Nigeria, one company is helping to reduce waste through recycling.

Freee Recycle is transforming old tyres into paving bricks, floor tiles, flip flops and other

goods and since its launch in 2018, the company have recyled over 400,000 tyres into new products.

Managing Director, Ifedolapo Runsewe says it's not hard to spot the problem of waste on Nigeria's streets.

"I think if you take a five minutes' walk or ten minutes' walk, and I guarantee you that you will spot at least ten tyres, right? Then you find them in drainages, you find them in street corner at where they ideally shouldn't be," she says.

Recycling process

The tyres are processed and cut into small pieces.

They're then mixed with an adhesive that lets workers shape the waste into all manner of products.

"(Tyres are) quite versatile in terms of the materials they are made from, talk of the rubber, which is mostly what we work with here, and even the steel, which is quite valuable," says



Runsewe. "And then you also have the fibre as well, which has its own uses and application."

The company's most popular product is its rubber paving stone, which costs about \$60 for a set of 40.

The slightly higher cost of Freee products is due to their extended shelf life compared to their traditional counterparts, the company says.

The products are available in major Nigerian cities, including Lagos, Abuja, and Port Harcourt.

Bolanle Emmanuel, Oyo state coordinator of the Nigerian Export Promotion Council, says one of the challenges will be "getting the raw materials down to these sites".

"This is the only recycling, tyre recycling industry that I've seen in Nigeria. I feel to get these challenges mitigated, they can replicate this center in different communities where they can crush the tyres so that it will

compress the volume into bags. When they are crushed into different sizes, it could easily be carried to where they will make use of it in final products."

Environmental solution

Freee Recycle believes it has prevented more than 8,100 tonnes of CO2 emissions since it began.

"Environmentally, they're making good use of material, which is usually sent to waste or burnt, which causes major air pollution," says Eid Zouki, a construction engineer, who recently commissioned Freee Recycle to supply a flooring solution for a school. "Maybe on a larger scale, now we have

"Maybe on a larger scale, now we have a more environmentally conscious society worldwide, the trend to using sustainable materials, reusing, recycling and making good use of materials usually sent to waste will catch on and eventually it will catch on in Africa."

Senate Move To Increase Customs 2024 Revenue Target

he Senate has stated it will likely review upwards the N5.079 trillion 2024 revenue target of the Nigeria Customs Service (NCS) from the second half of the year to save the country from further borrowings.

Disclosing this in Abuja recently, at a crucial meeting with the Comptroller General of the NCS, Adewale Adeniyi and top management of the revenue agency, Chairman, Senate Committee on Customs, Isah Jibrin, APC, Kogi East said, "first of all, Nigeria is saddled with lot of debt obligations and we need to wriggle ourselves out of that trap and one of the ways to do that is internally generated revenue. Customs is one of the major providers of internally generated revenue and as it is today, we expect them to play one of the major roles in this drive to reduce our debt burden.

"We need to pay off what we are owing now and minimize additional loans we are going to take. Customs is in a very good position, if they are able to block all perceived leakages, they should be able to generate significant amount of income that will enable Nigeria get out of debt, at least partially."

On concessions given to some sectors of the economy for example, agriculture, Jibrin noted that it was for those who are into agricultural services, those who are into solid minerals and those whose services have direct impact on the economy.

According to him, "If somebody is bringing agricultural equipment into the economy and you try to take something out of that person in a way of import duty, that will discourage the person and that is what we are saying. It is not that any body took that money or custom compromised in the course of their services.

"Concessions were in the interest of Nigeria to encourage importers who are going into specific areas in the economy. There is a trade off here between importers and the country, particularly the things you think you are generating."

Lekki Port Berths Biggest Vessel On Nigerian Waters

ekki Port, Nigeria's most modern and deepest seaport, has successfully berthed the MAERSK EDIRNE, a 13,092 TEUs vessel. This is the largest container vessel, to ever berth in Nigeria till date. The container vessel docked at Lekki Port at 14.42 hours on Sunday January 21, 2024.

The MAERSK

EDIRNE is one of 13 large container vessels which form the new CMA CGM WAX service that will operate along key locations including Xiamen, Qingdao, Shanghai, Singapore, Lekki Port, and Abidjan.

According to the Lekki port company, "This marks a pivotal moment in our



maritime history as Lekki Port proudly joins the esteemed CMA CGM West Africa express service, as the only port in Nigeria that is in this impressive port rotation.

"This is a testament to Lekki Port's capability to accommodate large container vessels, solidifying its

position as a key player in global trade.

"The MAERSK EDIRNE is a container ship with a length overall (LOA) of 366 meters and a width of 48 meters.

"This is a great win for Nigeria and the beginning of a new era of maritime excellence.

"Stay tuned for weekly calls of 13,000/14,000 TEUs vessels! We are

extremely grateful to the NPA team of pilots and other professionals who steered the vessel safely to berth.

"The next vessel that will be calling at Lekki Port is the magnificent CMA CGM SCANDOLA, an LNG powered vessel with a carrying capacity of 14,000 TEUs, on January 29."

Lekki Free Port Terminal Activates Vehicle Booking System

In order to ensure free flow of traffic within the port and to cut cost and facilitate trade for its customers, the management of the Lekki Free Port Terminal has said that it has taken some measures towards this

Speaking during the question and answer session at the 2024 Roadshow organized by the Lekki Port and Lekki FreePort Terminal in conjunction with the Customs Area Controller of the Lekki free Trade Zone Command, Comptroller Mohammed Babandede in Lagos recently, the Chief Commercial Officer, Lekki FreePort Terminal, Mr. Kehinde Olubi-Neye said that their customers have nothing to be afraid of as the shareholding structure of the port including the Lagos State Government was such that it could not afford to fail.

Declaring that Vehicle Booking System, VBS had come to stay at the port, Olubi-Neye informed that when they started putting in place the VBS, they did it with an understanding what the market requires and the control over access to the port.

He said, "We have been in engagement with the Lagos State Government, the Commissioner for Transport, Daniel Fubara has been quite active on that and we are discussing the roll out of the call up system. When we are in these meetings, they know how much we voice the need to ensure that this system supports vehicular movement. "So, the plan for call up system is that it will be engraved in our own vehicle booking appointment for our own vehicle booking system. So, we are not going outside our own truck appointment system to execute call up. It's a different case in Apapa or Lagos today. For us, it's still the system you are using that you will use

for your call up.

"You have touched the fact that there are people at the junction making things difficult. Thank you for that observation, we will immediately raise it. This is the first time I am hearing it, I have never seen that happen and we engage with customers daily but now you have raised it up to us, we will take it. But this is why we also need to have a robust traffic management system within the port community. If we do not get the law enforcement to eradicate and support the movement of traffic into the port area, then, we will have challenges. And some of these challenges is what you have mentioned.

"But if the traffic management authority can see from our own vehicle booking system, these are the people who are supposed to come to the port, then, they will be able to effectively manage it".

Inflation, Weak Foreign Exchange, Safety Forcing Review Of Handling Rate -Ground Handling Companies

round Handling Companies in Nigeria have cried out over the current unfavourable conditions in which they operate because of the current economic realities on ground.

In a letter written by the Aviation Ground Handling Association of Nigeria (AGHAN), dated January 26, 2024, and signed by Mr. Olaniyi Adigun, the AGHAN Chairman and Ahmed Bashir Gulmah, AGHAN Vice Chairman, to the Director General of the Nigerian Civil Aviation Authority (NCAA), the association listed the weak foreign exchange regime against the Naira, increase in diesel cost among others as reasons why the current handling rates needs urgent review.

It would be recalled that the last time domestic handling rates were reviewed in Nigeria was in September 2021 and the reviewed rates came into effect in January 2022 exactly 2 years ago. This was at a time when the United States dollar was N400 to a dolla, but today, a dollar is over N1300.

The association stated that "As ground handlers, all our equipment and spares are imported 100% and we have had to grapple with the consistent decline of the naira in the foreign exchange market for the past 24 months.

"On the local side, inflationary pressure has seen cost as diesel and other local consumables cost rise by over 200% since 2021. In addition, ground rent charged by FAAN was increased 100% while other charges such as apron passes have gone up by over 200%.

"We note that despite all these, ground handling rates have been remained static for the past 24 months. The ground handling subsector of the aviation industry has over the years absorbed the economic shocks for the sector."

The base rate for domestic ramp operations as approved by NCAA in 2021 and the proposed new rates are detailed below:

AGHAN reasons that "it is important that this is redressed to enable the ground handling companies continue to provide



services in a safe and secure manner.

"With the paltry sum that we charge and have been charging over the years, there is no way the ground handling industry aviation sector will be able to be efficient and sustainable.

"The current rates are not sustainable because of the impact of drop in naira against major currencies and impact on purchase of the Ground Support Equipment (GSE) and provision of facilities used in servicing the aircraft that are all procured abroad."

According to the association, "the five registered ground handling companies provide over 200,000 direct and indirect employments to Nigerians with material macroeconomic contributions to the Nigerian economy.

"We operate integrated Customs Bonded Warehouses in the five major airports (Lagos, Port-Harcourt, Abuja, Enugu, and Kano) in the country, thereby contributing to Federal Government Revenue Generation."

AGHAN also noted that "international and domestic airlines have consistently reviewed upward air tickets over the years, while the handling rates for ground handling companies have remain the same within the period.

"On the domestic side, Lagos and Abuja flight for instance ranges between N90,000 to N150,000 for an economy class ticket depending on the airline, class of the ticket and the period of the booking activated by an air traveller.

"For the international operators, with today's rate, the cheapest flight on any airline; Lagos-London is \$1,500 to \$2,500 (economy seat). Yet, the handling rates have reduced despite the skyrocketing prices of equipment and machines and the constant change in air fares in the past 2 years!

"It is observed that globally 70 to 80 per cent of accidents start from the ground. So, to prevent these, the current rates needed urgent reviews.

"AGHAN hereby requests the cooperation of NCAA to support and favourably consider the new domestic handling rates as proposed in the table above, which will take effect from 31 March 2024", the association stated.

The Aviation Ground Handling Association of Nigeria (AGHAN) is an association of ground handling companies in Nigeria, formed in 2019 primarily to promote safer handling, engage in profitable collaboration and form progressive partnership, to enhance service efficiency and standards.

Since its formation, the association has interacted with the Federal Government, Airlines, and other Stakeholders to put necessary regulations and policies in place.

Ibom Air Ends Wet Lease Aircraft Operations



bom Air has announced that it is ending its wet leased aircraft operations. This is according to a Press Release signed by Ibom Air General Manager, Marketing and Communication, Aniekan Essienette. Justifying the action as part of the company's long-term fleet programme, the GM stated that "This comes in the wake of the delivery of the company's brand-new Airbus A220-300 aircraft, the first of 10 ordered from Airbus in October 2021.

"With the imminent entry into service of the A220, the 'place holding' work of the 2 wet-leased Airbus A320s now comes to an end."

According to the Airline's Executive Director and Chief Operating Officer, Mr George Uriesi, "we resorted to wet leasing aircraft to meet the growing demand for our product, while we worked on our fleet growth programme. Now with these aircraft being delivered, it is time for us to

benefit from the significant operating efficiencies and enhanced service the A220-300 brings to the business".

Ibom Air explained that "The A220 could not have come to Ibom Air at a better time, when the airline business in Nigeria badly needs operationally efficient aircraft that consume 25% less fuel than other aircraft in its category, while offering class leading comfort, safety and environmental friendliness.

"The transition from the wet leased aircraft will result in a reduced flight schedule for a few weeks as the first two A220s are phased into service.

The COO added that "We apologize in advance for any inconvenience our reduced schedule may cause as we transition into a period of better and stable all round service, with these new equipment."

Nigeria Moves To Streamline Travel Time With Trinidad And Tobago

a move to streamline travel time between Nigeria and Trinidad and Tobago, the Hon. Minister of Aviation and Aerospace Development, Festus Keyamo, recently, convened a crucial meeting with the High Commissioner of the Republic of Trinidad and Tobago to Nigeria, Ambassador H.E Wendell V.C De Landro and his delegation in Abuja.

The primary agenda of the meeting was to ratify the longstanding Bilateral Air Services Agreement (BASA), between Nigeria and the Caribbean Island nation, paving the way for a direct flight connection between the two countries.

The initiative stems from the recognition that the current travel routes between Nigeria and Trinidad and Tobago are arduous and time-consuming, often taking up to 24 hours or more on connecting flights. However, with a direct flight, the journey can be completed in just 7 and a half hours. This significant reduction in travel time is poised to revolutionise bilateral relations and enhance economic and cultural exchanges between the two nations.

The BASA agreement, originally initiated in 2009, had not been ratified until now. High Commissioner De Landro expressed his fervent commitment to expediting the process, highlighting the immense potential for increased tourism, entertainment, and commerce that a direct flight connection would bring.

In response, Honourable Minister Keyamo commended the High Commissioner's initiative, noting the profound cultural similarities between Nigeria and Trinidad and Tobago. He remarked, "This agreement is commendable and timely. It will not



only foster closer ties between our nations, but also unlock numerous economic opportunities."

To ensure swift progress, the Minister

has directed the establishment of a dedicated working committee, tasked with expediting the ratification process and facilitating the involvement of a dedicated airline to service the direct route.

This historic meeting marks a significant step towards enhancing connectivity and

cooperation between Nigeria and Trinidad and Tobago, ushering in a new era of collaboration and prosperity.

NCAA Reads Riot Act To Domestic Airlines On Flight Delays

he Nigeria Civil Aviation Authority NCAA has expressed displeasure at the reports of incessant delays, flight disruptions, and schedule changes without adequate notice to passengers. The Acting Director General, Captain Chris Najomo, reiterated the need for airlines to improve their services as the Minister of Aviation and Aerospace Development, Mr. Festus Keyamo is determined to enforce his five point agenda as mandated by President Bola Tinubu.

According to him, the current record of flight disruptions, poor customer experience and poor handling of passengers is unacceptable and must be improved upon to satisfy the needs of the passengers.

He said airlines "must consider scheduling flights into sunset airports early in the day so as to minimize cancellations as a result of airport closure at sunset and NCAA will ensure that airlines fulfil their obligations to passengers or face sanctions."

"Airlines must handle persons with

reduced mobility properly, with dignity and without discrimination as airlines are mandated to provide facilities for the movement of Persons with reduced mobility and by virtue of the provisions of Nigeria Civil aviation regulations part 19,"

"Similarly airlines are required to provide on their ticket portal a mandatory field for special needs assistance and require their agents to actively ask customers during ticket purchase if they will require assistance" he reiterated.

"Also it is no longer business as usual as errant airlines will be sanctioned appropriately without fear or favor and NCAA has stepped up its surveillance to monitor compliance with a view to fish out violators."

The Director, Consumer Protection & Public Affairs, Mr. Michael Achimugu, emphasised that the Authority will not relent in its commitment to ensure pleasurable travel experience and comfort for air transport passengers. The Airlines present committed to work on all issues raised and make adjustments where necessary.

China Beats Japan, Becomes World's Biggest Car Exporter

hina's global dominance in electric cars helped it overtake Japan as the world's biggest vehicle exporter last year, official data confirmed recently.

Japanese giants such as Toyota and Nissan have been much more cautious than their Chinese counterparts like BYD on electric vehicles (EVs), banking instead on hybrid models.

Figures released by the Japan Automobile Manufacturers Association showed shipments of cars, trucks and buses rising 16 percent to 4.42 million last year.

But China exported almost 500,000 more-4.91 million vehicles in total, as reported by the China Association of

Automobile Manufacturers this month. China's customs bureau put the number even higher at 5.22 million, a huge year-on-year rise of 57 percent, with one in three fully electric vehicles.

The country had already been shipping more vehicles than Japan on a monthly basis, but data confirmed that it was







also number one for a whole year. Unlike Chinese firms, Japanese

automakers including Toyota reconfirmed recently as the world's largest company by unit sales also make huge volumes of vehicles in other countries.

In 2022, vehicle production in Japan excluding motorcycles totalled 7.84

million units, but overseas production was almost 17 million.

Japanese manufacturers have long bet on hybrids that combine battery power and internal combustion engines, an area they pioneered with the likes of the Toyota Prius.

But they have vowed to up their game, with Toyota aiming to sell 1.5 million EVs annually by 2026 and 3.5 million by 2030.

The company is also hoping to mass-produce solid-state batteries that charge faster than conventional ones and give EVs more range.

Helped by strong government support, Chinese EV firms

have stolen a march on more established rivals such as General Motors, Volkswagen and Toyota.

BYD in the fourth quarter of 2023 even snatched Tesla's crown for most sales of all-electric vehicles, data this month showed.

OPEC Releases \$1.7bn For Energy Projects In Africa, Others

he Organization of Petroleum Exporting Countries, (OPEC) Fund for International Development in 2023, has financed 55 projects worth \$1.7b, in which a Nigerian solar plant and an Azerbaijan wind farm were among the beneficiaries.

Aligned with the multilateral development finance institution's Climate Action Plan, support for renewable energy projects constituted nearly 60 per cent of all

lending in the energy sector, according to a press release.

The fund supported a \$25 million solar plant in Niger, a \$50 million 240megawatt wind farm in Azerbaijan, and contributed \$40 million to two wind power plants, totaling 1 gigawatt of renewable energy capacity in



Uzbekistan.

The OPEC Fund's investments in the energy sector included projects dedicated to enhancing energy security in Tanzania and Bangladesh, aligning with the objectives of Sustainable Development Goal 7 ensuring clean and affordable energy access.

Additionally, the allocated capital aimed to tackle pressing issues such as climate change, social and economic resilience, and sustainable growth.

Navy Arrests Five Suspects With Vandalised Railway Tracks In Kaduna



he Nigerian Navy School of Armament Technology (NNSAT), Kachia Local Government Area, Kaduna State said it had intercepted three trailers loaded with vandalised railway tracks.

The NNSAT Commandant, Commodore Henry Aruomaren, made this known at a news briefing in Kachia recently.

The suspects and the seized railway tracks have been handed over to the Nigeria Security and Civil Defence Corps (NSCDC) for profiling and

further investigation.

Aruomaren said the feat was in continuation of the fight against criminal activities within Kaduna State and its environs.

"The NNSAT Kachia internal security checkpoints at Makyali, Kachia LGA, acting on actionable intelligence at about 0500 on Feb. 2, intercepted the three trailers.

"The trailers with registration numbers ABJ 897 XB, MGU 232 ZF and XG 276 JJN, respectively, were laden with vandalised railway track materials

concealed with animal feeds," he said.

The commandant said the vandalised railway tracks ran through Katul-Crossing in Kachia LGA to Kafanchan.

He said that the railway tracks had not been in use for some time hence, criminal elements devise means to make it a source of income by vandalising and selling off the metal irons.

"Reportedly, the suspects were arrested by the internal security checkpoint team during

a stop and search operation.

"Consequently, the base was informed of the arrest and a Strike Force was dispatched to the scene of the arrest to move the suspects and the exhibits to the Base for further investigation.

"It suffices to state that, only one of the three trailer drivers was arrested while others absconded when they got the information that NNSAT internal security checkpoint had arrested the first trailer, "he said.

Lagos Destroys Shanties, Dislodge Squatters Under Ijora Bridge

he Lagos State Government has destroyed illegal shanties occupied by squatters under the Ijora Causeway Bridge. The government had earlier given a five-day quit notice to squatters under the bridge and the Lagos Blue rail Line overhead bridge in Ijora to remove all their shanties for constituting a danger to the Lagos Blue Line corridor or risk demolition and removal.

The state Commissioner for the Environment and Water Resources, Tokunbo Wahab, while giving the quit

notice lamented the security risk the occupation of underneath the bridge by mini buses, block moulders, fuel sellers and miscreants posed to the safe operation of the blue rail line service, and said the government would not allow it to continue.

Sharing videos on his X handle recently, Wahab stated that the enforcement team was led by ACP Bayo Sulaiman under the directive of the state governor to dislodge the squatters and clear the area.

He wrote, "Following the expiration of

a 5-day quit notice issued to squatters under the Ijora Causeway Bridge by #followlasg last Sunday, the Enforcement Team of the Lagos State Ministry of the Environment and Water Resources #LasgMOE and Special Intervention Squad on the Restoration of the Lagos Badagry Rail Corridor Clean-Up led ACP Bayo Sulaiman begin enforcement by dislodging the illegal squatters and clearing up the area as directed by Lagos State Governor, #jidesanwoolu."



Lobito Atlantic Railway To Transport Minerals

rafigura and Kamoa-Kakula have agreed to long-term commitments to transport minerals via the Lobito Atlantic Railway for a minimum term of six years. The terms of the Reserved Capacity Agreements were signed during the Mining Indaba in Cape Town, South Africa and mark the first long-term commercial commitments to the Lobito Atlantic Railway, a new import-export trade route between the African Copperbelt and Angola's Atlantic coast.

The Lobito Atlantic Railway is expected to ramp up to an annual export capacity of one million tonnes per annum before the end of the decade. Trafigura's allocation of export capacity on the Lobito Atlantic Railway will be up to 450,000 tonnes per annum from 2025.

In addition, the Kamoa-Kakula copper complex, a joint venture between Ivanhoe Mines and Zijin Mining, has been allocated a minimum capacity of



120,000 tonnes and up to 240,000 tonnes per annum of copper products blister-anode or concentrate from 2025, with an initial commitment of 10,000 tonnes to be transported in 2024 as the railway ramps up.

In 2022, the Lobito Atlantic Railway consortium, comprising Trafigura, Mota-Engil and Vecturis, was awarded a 30-year concession for the operation,

management and maintenance of the Lobito Atlantic Railway (LAR) and for the Lobito Minerals port. The upgraded line will provide a more efficient and lower-carbon route to market for copper, cobalt and other metals crucial to the energy transition and will operate on the basis of open commercial access.

Jeremy Weir, Executive Chairman and CEO of Trafigura commented: said"We are pleased to be one of the first commercial customers to agree terms for a long-term commitment to use the Lobito Atlantic Railway and we look forward to welcoming other customers to join Ivanhoe Mines and Trafigura in the coming months.

"These commitments announced today support the consortium's aim to grow the volumes on the corridor so that it becomes the leading rail transport link in sub-Saharan Africa."

Ivanhoe Mines' Founder and Executive Co-Chairman, Robert Friedland commented: "We admire the hard work of the Lobito Corridor consortium and Trafigura, working with their partners in the Democratic Republic of the Congo and Angola, to build a new supply chain that is fast becoming one of the most important trade routes for vital copper metal in the world."

Germany Sells Shares In Postal Company To Help Finance Railway Improvements

ermany's state-owned development bank has sold shares in the company that owns the national postal service for about 2.17 billion euros (\$2.3 billion), reducing the government's stake and raising money to help finance improvements to the country's rail network.

The KfW bank, which holds the government's remaining stakes in previously state-held companies, said recently that it had sold 50 million shares of Deutsche Post the name under which it still trades on the stock exchange, although the company is now known as DHL Group at 43.45 euros each. That amounts to 4% of the company's shares.

The sale cuts the state's stake in DHL to 16.5%, though it is still the largest

single shareholder. The proceeds are to be used to strengthen the capital of Germany's main railway operator, the state-owned Deutsche Bahn, to help it upgrade railway infrastructure, the Finance Ministry said.

The government is turning to privatization proceeds to help finance improvements to the rail network after a court ruling forced it to plug a big hole in this year's budget and reconsider its wider financial plans.

In November, Germany's highest court annulled a decision made by the government in 2022 to repurpose 60 billion euros originally meant to cushion the fallout from the COVID-19 pandemic for measures to help combat climate change and modernize the country.


