



VACANCY FOR THE POST OF REGISTRAR

The Governing Council in the exercise of its powers, as enshrined in the University's Act No. 34 of 2022, decided to commence the process to fill the vacancy of the Registrar of the University. Consequently, the University hereby invites applications from suitably qualified candidates for the position of Registrar.

Position and Duties

The Registrar is the Chief Administrative Officer of the University and shall be responsible to the Vice Chancellor for the day-to-day general administrative work of the University. The Registrar shall also be the Secretary to Council, the Senate, Convocation and Congregation of the University and shall perform any other duties that may be assigned to him/her by the Vice-Chancellor. A successful candidate will be required, among other things, to train and give good professional leadership to administrative staff to ensure efficient and effective professional administrative performance.

Qualifications

Candidates must:

- Possess at least a Second-Class Lower degree from a recognized University
- Be proficient in ICT and must be current in deploying it at the level required for efficient job performance
- Be a member of at least one relevant professional body e.g. NIM, IPMN, ANUPA

The possession of higher degrees in relevant programmes will be an advantage.

Experience

- The candidate must have at least fifteen (15) years post-qualification experience, twelve (12) of which must be in University Administration.
- The applicant must have spent a minimum of three (3) years as Deputy Registrar in a recognized University.

Age

Candidate must not be older than 60 years at the date of appointment.

The Governing Council in the exercise of its powers, as enshrined in the University's Act No. 34 of 2022, decided to commence the process to fill the vacancy of the Bursar of the University. Consequently, the University hereby invites applications from suitably qualified candidates for the position of Bursar.

Position and Duties

The Bursar is a Principal Officer and the Chief Finance Officer of the University. He/she is responsible to the Vice Chancellor for:

- day-to-day administration and control of the financial affairs of the University;
- advising on financial policies, budgeting, disbursement of funds, purchasing and contracts;
- preparation and presentation of annual estimates, planning, control and periodic evaluation of university accounting and treasury service, including investment of funds;
- preparation and updating of Manual of Financial Procedures; and
- carrying out other duties as may be assigned and provide professional and community service.

Qualifications

Candidate for the post of Bursar should:

- Possess a bachelor's degree in accounting not below second class from a recognized University;
- Be a full member of any recognized Professional Accountancy Body such as ICAN, ANAN, ACCA;
- Possess NYSC discharge/exemption certificate;
- Have a minimum of fifteen (15) years post-qualification cognate experience, three (3) years of which must be in top Management position, preferably at Deputy Bursar's level in a public tertiary institution or cognate experience of eighteen (18) years with a minimum of two (2) years as Deputy Bursar in a public tertiary institution;
- Be able to demonstrate the ability to formulate and implement financial policies and produce manuals of university financial procedures;
- Be computer literate with a working knowledge of relevant accounting packages;

The University Librarian is a Principal Officer of the University responsible to the Vice Chancellor for the administration of the University Library and the coordination of all library services in the University. For the vacant post, the University seeks candidates with vision, proven academic distinction, managerial ability, integrity and requisite professional skills and competences. The candidate must be innovative with good professional leadership and should understand the nature and dynamics of the best practices in the provision of academic library services. Other duties include:

- Operations of the University's Library and its constituent units;
